

# Certificate of Location of Lode Mining Claim

THIS IS TO CERTIFY that the Gessen # 3 Lode Mining Claim was located by G. E. Morse & partners, whose post office address appears below, on the 5 day of May, 1969.

The general course of said lode or vein is Northerly, easterly + Southerly westerly  
The claim is situated in the ~~XXXX~~ unknown Mining District, Eureka

County, State of Nevada, in the area known as twin peaks at the head of Davis Canyon - N.W. corner quit quit survey monument

The locator's claim 1200 feet in a southerly direction and 300 feet in a Northerly direction from the point of discovery, with a width of 200 feet on each side of the center of the vein or lode along the entire length of said claim.

The dimensions and locations of the discovery work done on the claim are as follows:

opened & cleared cuts, repair roads & haul system

The total cost of such work consisted of at least \$100.00

The corners and side centers of the claim are located and marked as follows:

From the N.E. corner corner, a monument marked Gessen # 3 N.E. Cor., thence in a lastly direction 200 feet to the N.E. corner, a monument marked Gessen # 3 N.E. Cor., thence 250 feet in a Southerly direction to the last side center, a monument marked Gessen # 3 E. SC, thence 250 feet in a southerly direction to the S.E. corner, a monument marked Gessen # 3 S.E. Cor., thence 200 feet in a westerly direction to the S.W. corner, a monument marked Gessen # 3 S.W. Cor., thence 750 feet in a Northerly direction to the West side center, a monument marked Gessen # 3 W. SC, thence 750 feet northerly to the point of beginning.
