

Certificate of Location of Lode Mining Claim

THIS IS TO CERTIFY that the Gorran # 5 Lode Mining Claim was located by G. E. Morse & partners, whose post office address appears below, on the 2 day of May, 1969.

The general course of said lode or vein is easterly & westerly

The claim is situated in the Uniontown Mining District, Eureka County, State of Nevada, in the area known as Twin peaks at the head of Denis Canyon - tunnel & shaft on south side of south granite peak

The locator's claim 750 feet in a westerly direction and 750 feet in a easterly direction from the point of discovery, with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

The dimensions and locations of the discovery work done on the claim are as follows:

cleared cuts, repair roads & hand exposure

The total cost of such work consisted of at least \$100.00

The corners and side centers of the claim are located and marked as follows:

From the S.W. corner, a monument marked Gorran # 5 S.W. Cor., thence in a Northerly direction 300 feet to the N.W. corner, a monument marked Gorran # 5 N.W. Cor., thence 750 feet in a easterly direction to the North side center, a monument marked Gorran # 5 N. SC, thence 750 feet in a easterly direction to the N.E. corner, a monument marked Gorran # 5 N.E. Cor., thence 300 feet in a Southerly direction to the S.E. corner, a monument marked Gorran # 5 S.E. Cor., thence 750 feet in a westerly direction to the South side center, a monument marked Gorran # 5 S. SC, thence 750 feet west to the point of beginning.

Each of the above-described monuments is at least 4 inches diameter by 4 feet 6 inches 10 deep set in ground

All location and discovery work necessary to complete this location had been performed by May 2, 1969.
