

Certificate of Location of Lode Mining Claim

THIS IS TO CERTIFY that the Gosson #10 Lode Mining Claim was located by G. E. Morse & partners, whose post office address appears below, on the 2 day of May, 1969.

The general course of said lode or vein is so. westerly & north easterly.
 The claim is situated in the unknown Mining District, Lumbas County, State of Nevada, in the area known as twin peaks at the head of Basin Canyon - joins base claim #1 and #2 on west side line.
 The locator's claim 300 feet in a Northwesterly direction and 1200 feet in a southwesterly direction from the point of discovery, with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

The dimensions and locations of the discovery work done on the claim are as follows:
cleaned cut, repair roads & travel expenses

The total cost of such work consisted of at least \$100.00.

The corners and side centers of the claim are located and marked as follows:
 From the Northwest corner, a monument marked Gosson #10 N.W. Cor., thence in a east direction 300 feet to the N.E. corner, a monument marked Gosson #10 N.E. Cor., thence 750 feet in a south direction to the east side center, a monument marked Gosson #10 E. SC, thence 750 feet in a southwesterly direction to the S.E. corner, a monument marked Gosson #10 S.E. Cor., thence 300 feet in a westerly direction to the S.W. corner, a monument marked Gosson #10 S.W. Cor., thence 750 feet in a northwesterly direction to the west side center, a monument marked Gosson #10 W. SC, thence 750 feet northwesterly to the point of beginning.

Each of the above-described monuments is 1/2" galv. pipe 4" dia. in hole 4 ft. diameter in length set in ground.
 All location and discovery work necessary to complete this location had been performed by MAY 2, 1969.
