

# Certificate of Location of Lode Mining Claim

THIS IS TO CERTIFY that the Benson #16 Lode Mining Claim was located by E.H. Drellinger, whose post office address appears below, on the 21 day of JUNE, 1969.

The general course of said lode or vein is Northerly & Southerly. The claim is situated in the W.M.K. Nakan Mining District, Eureka County, State of Nevada, IN THE AREA KNOWN AS Twin Peaks at the head of Davis Canyon S.E. of spring on road #11.

The locator's claim 750 feet in a Northerly direction and 750 feet in a Southerly direction from the point of discovery, with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

The dimensions and locations of the discovery work done on the claim are as follows: Clenned cuts, Repair Roads, Travel Expenses

The total cost of such work consisted of at least \$100.00. The corners and side centers of the claim are located and marked as follows: From the Northwest corner, a monument marked Gordon #16 N.W. Cor., thence in a Westerly direction 300 feet to the N.E. corner, a monument marked Gordon #16 N.E. Cor., thence 750 feet in a Southerly direction to the East side center, a monument marked Gordon #16 E. SC, thence 750 feet in a southwesterly direction to the S.E. corner, a monument marked Gordon #16 S.E. Cor., thence 300 feet in a northerly direction to the S.W. corner, a monument marked Gordon #16 S.W. Cor., thence 750 feet in a Northerly direction to the West side center, a monument marked Gordon #16 W. SC, thence 750 feet Northerly to the point of beginning.

Each of the above-described monuments is A post at least 4 inches diameter 4 feet in length set in ground.
