

Certificate of Location of Lode Mining Claim

THIS IS TO CERTIFY that the GISSAN #19 Lode Mining Claim was located by E.H. Drolenger & Partners, whose post office address appears below, on the 26 day of JUNE, 1969.

The general course of said lode or vein is Northerly + Southerly. The claim is situated in the UNKNOWN Mining District, EUREKA County, State of Nevada, in The AREA KNOWN AS TWIN PEAKS AT THE HEAD OF DAVIS CANYON - just beyond #14 on east side line.

The locator's claim 750 feet in a Northerly direction and 750 feet in a Southerly direction from the point of discovery, with a width of 750 feet on each side of the center of the vein or lode along the entire length of said claim.

The dimensions and locations of the discovery work done on the claim are as follows:

Cleared cuts, Repair Roads, TRAVEL Expenses

The total cost of such work consisted of at least \$101.00.

The corners and side centers of the claim are located and marked as follows:

From the Northwest corner, a monument marked Grass #19 N.W. Cor., thence in a Northerly direction 300 feet to the N.E. corner, a monument marked Grass #19 N.E. Cor., thence 750 feet in a Southerly direction to the east side center, a monument marked Grass #19 E.S.C., thence 750 feet in a Southerly direction to the S.E. corner, a monument marked Grass #19 S.E. Cor., thence 300 feet in a Westerly direction to the S.W. corner, a monument marked Grass #19 S.W. Cor., thence 750 feet in a Northerly direction to the west side center, a monument marked Grass #19 W.S.C., thence 750 feet Northerly to the point of beginning.

Each of the above-described monuments is approximately 4 inches diameter 1 foot 1 inch in length, set in ground.
