

Certificate of Location of Lode Mining Claim

THIS IS TO CERTIFY that the Gossen #22 Lode Mining Claim was located by E. H. Drellinger & Partners, whose post office address appears below, on the 29 day of June, 1969.

The general course of said lode or vein is Northerly + Southwesterly.

The claim is situated in the Mr. Kraus Mining District, Eureka County, State of Nevada, in The Area Known As Twin Peaks. At the head of Davis Canyon - northeast corner of group claims.

The locator's claim 750 feet in a Easterly direction and 750 feet in a Westerly direction from the point of discovery, with a width of 360 feet on each side of the center of the vein or lode along the entire length of said claim.

The dimensions and locations of the discovery work done on the claim are as follows:

Cleared cuts, Repair Roads, Travel Expenses

The total cost of such work consisted of at least \$100.00.

The corners and side centers of the claim are located and marked as follows:

From the Northwest corner, a monument marked Gossen #22 N.W. Cor., thence in a Westerly direction 300 feet to the N.E. corner, a monument marked Gossen #22 N.E. Cor., thence 250 feet in a Southerly direction to the East side center, a monument marked Gossen #22 E. SC., thence 750 feet in a southerly direction to the S.E. corner, a monument marked Gossen #22 S.E. Cor., thence 300 feet in a Westerly direction to the S.W. corner, a monument marked Gossen #22 S.W. Cor., thence 750 feet in a Northerly direction to the West side center, a monument marked Gossen #22 W. SC., thence 750 feet Northerly to the point of beginning.

Each of the above-described monuments is a post at least 1 inch in diameter 4 feet high, set in ground.
