

# Certificate of Location

THIS IS TO CERTIFY that the Bowser 23-A lode mining claim was located by Mount Hope Mines Company on the 30th day of April, 1969.

The general course of said lode or vein is northerly-southerly.

The claim is situated in the Mount Hope Mining District, Eureka County, State of Nevada. This claim is situated 4100 feet east of Mount Hope Peak and adjoins Bowser 25-A on the west side line and Bowser 23 on the north end line and overlaps the Silver Butte No. 2 Patent on the south end line.

The locator's claim is 25 feet in a(n) northerly direction and 1475 feet in a(n) southerly direction from the point of discovery, with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

The dimensions and locations of the discovery work done on the claim are as follows:

Location work for Bowser 29-A, Bowser 27-A, Bowser 25-A, Bowser 23-A, Bowser 21-A was done as a group. These claims are contiguous. 350 ft. southerly from the northwest corner of Bowser 25-A and the northeast corner of Bowser 27-A, a cut 12 ft. wide, 4 ft. deep and 200 ft. long, running easterly & westerly. At least \$500.00 work done on these five claims.

The corners and side centers of the claim are located and marked as follows: From the southwest corner a post marked Bowser 23-A S.W. Cor., thence in an easterly direction 600 ft. to the southeast corner, a post marked Bowser 23-A S.E. Cor., thence 750 ft. in a northerly direction to the east side center, a post marked Bowser 23-A E.S.C., thence 750 ft. in a northerly direction to the northeast corner, a post marked Bowser 23-A N.E. Cor., thence 600 ft. westerly to the northwest corner, a post marked Bowser 23-A N.W. Cor., thence 750 ft. in a southerly direction to the west side center, a post marked Bowser 23-A W.S.C., thence 750 ft. in a southerly direction to the point of beginning.

Each of the above-described monuments is a post at least four inches in diameter by four feet six inches in length, set one foot in the ground.

All location and discovery work necessary to complete this location had been performed by June 1, 1969.
