HEAD OF MEADOW CANYON, AN UNSURVEYED LAND AND JOINS THE VILLANOVA CLAIMS #1, 2, 3  
ON THE NORTH & EAST.

Locator's claim 1500 linear feet along the course of the mineral-bearing ledge, lode or vein, ex-  
tending 1200 feet from the location monument in a WESTERLY direction and 300

feet in a EASTERLY direction, together with 300 feet on each side of the center of the  
vein for the entire length of the claim. (Use reverse side for multiple locations.)

The northwest corner is marked by a Post 4 1/2 feet high, inscribed "NW Corner of the

Coronado #1 Claim"; the southwest corner is marked by a Post 4 1/2 feet high,

inscribed "SW Corner of the Coronado #1 Claim"; the southeast corner is marked by a Post

4 1/2 feet high, inscribed "SE Corner of the Coronado #1 Claim"; the northeast corner is

marked by a Post 4 1/2 feet high, inscribed "NE Corner of the Coronado #1 Claim."

There is also a Post at the center of each side line. (Use reverse side for multiple locations.)

Each of the described monuments is a post at least 4 inches in diameter by 4 feet 6 inches in length set 1 foot

in the ground.
