AMENDED ORDER THAT ESTATE OF LESS THAN \$1,000.00
BE ASSIGNED AND SET APART UNDER AUTHORITY OF N.R.S.146.070

WHEREAS, BEULAH K. MURPHY, the Petitioner named in the
above-entitled matter, did on December 4, 1968 file her Petition
that an estate of less than \$1,000.00 be not administered upon
and set aside to Petitioner; and

WHEREAS, in said Petition Petitioner listed seven (7)
unpatented lode mining claims situate in the LYNN MINING DISTRICT
of Eureka County, Nevada in which the above-named Deceased had
an undivided one-half interest at the time of her death; and

WHEREAS, by inadvertence Petitioner failed to list
among said lode mining claims the name of HILL TOP NO. 2 in which
the above-named Deceased likewise owned an undivided one-half
interest for a total of eight (8) unpatented lode mining claims
in which said Deceased owned an undivided one-half interest; and

WHEREAS, the above-entitled Court did make its order
dated December 23, 1968 setting aside the undivided one-half
interest of the above-named Deceased in and to the seven (7)
unpatented lode mining claims set forth in the Petition; and

1 WHEREAS, the addition of the one-half interest of the
2 above-named Deceased in and to the HILL TOP NO. 2 still does
3 not raise the value of said estate above \$1,000.00; and

4 WHEREAS, it is the desire of Petitioner, by and through
5 LEO J. PUCCINELLI, her attorney, to amend the original order of
6 the above-entitled Court filed on December 26, 1968 to the end
7 that the undivided one-half interest of the above-named Deceased
8 in and to all eight (8) unpatented lode mining claims will be
9 set aside to Petitioner, without administration, and good cause
10 appearing therefore, -

11 IT IS HEREBY ORDERED, ADJUDGED AND DECREED by the Court
12 that all of the estate of the above-named Deceased situate in
13 the State of Nevada be not administered upon, but that the whole
14 thereof be assigned and set apart to the Petitioner, BEULAH K.
15 MURPHY, of 5212 Eileen Drive, San Jose, California 95129, the
16 surviving sister of the above-named Deceased, which said estate
17 consists of an undivided one-half interest in and to eight (8)
18 unpatented lode mining claims situate in the LYNN MINING DISTRICT
19 of Eureka County, Nevada and more particularly described as
