

14 forever.



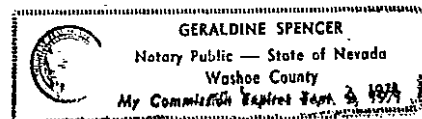
