AMENDMENT TO AGREEMENT

WHEREAS; the undersigned David H. Bissett, 3706 So. 198th St., Seattle, Washington, and Frank G. Foster, Box 321, Eureka, Nevada, hereinafter called Bissett and Foster, respectively, have entered into an agreement dated September 22, 1967, a copy of which is attached hereto, in which agreement Foster and Bissett agree to share in mining claims and acquisitions made by either within 30 miles of the county courthouse of Eureka, Nevada, and

WHEREAS, Bissett and Foster desire to alter and amend said agreement of September 22, 1967, as hereinafter set forth.

NOW THEREFOR, in consideration of the sum of ten dollars mutually exchanged, and in consideration of the covenants and agreements made by Bissett and Foster and to be kept and performed by them, it is agreed as follows:

Foster agrees that when he has received the sum of two hundred fifty thousand dollars (\$250,000.00) as a result of his ownership of mining locations staked and/or acquired by either Bissett or Foster or both together within five lineal miles of the Mount Hope Mine, Eureka County, Nevada, then Foster's interest and ownership in such mining locations and properties will cease and no further payments or royalties will be due him from such mining locations and properties.

Bissett agrees that he will make no assignment or transfer of mining locations staked and/or acquired by either Bissett or Foster or both together within five lineal miles of the Mount Hope Mine, Eureka County, Nevada, which assignment or transfer will result in termination of Foster's interest in such mining locations and properties until or unless Foster receives payments and/or royalties totalling at least one hundred thousand dollars (\$100,000.00) prior to termination of Foster's interest.

Foster agrees that when he has received the sum of two hundred fifty thousand dollars (\$250,000.00) as a result of his ownership of mining locations staked and/or acquired by either Bissett or Foster at the Whip Poor Will group of mining claims, Eureka District, book 19, pages 253 to 262 records of Eureka County, Nevada, and additional claims located by Bissett and/or Foster as contiguous expansions of said Whip Poor Will claim group, then Foster's interest and ownership in such mining locations and properties will cease and no further payments or royalties will be due him from such mining locations and properties.

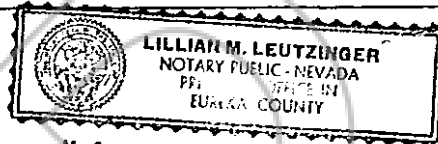
