Said labor was performed during the period between September 1, 1968, and August 31, 1969.



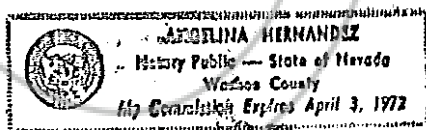
That all of said work was done and performed for the benefit of each and all of the unpatented lode mining claims hereinabove named.


