

GRANT DEED

THIS INDENTURE, made the 11 the day of October, one thousand nine hundred and sixty-nine,

BETWEEN Charles and Helen Halstead, hereinafter designated Grantors and Dik S. Buxton and Betty L. Buxton, as Joint-tenants, with right of survivorship, hereinafter designated Grantees.

WITNESSETH: That the said Grantors, in consideration of the sum of Ten Dollar's (\$10,00), lawful money of the United States, and other valuable consideration, to them in hand paid by the said Grantees, the receipt whereof is hereby acknowledged, do by these presents grant, bargain and sell unto the said Grantees, and to their heirs and assigns forever, all that certain parcel of land situated in the Town of Eureka, County of Eureka, State of Nevada, as follows, to-wit:

> All of Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, in Block Sixty-eight (68), as the same are delineated and described on the Official Map or Plat of the Townsite of Eureka, approved by the United States General Land Office on November 19, 1937, on file in the Office of the County Recorder of Eureka County at Eureka, Nevada, being that same property conveyed from Charles and Helen Halstead to Charles and Helen Halstead as joint-tenants with right of survivorship, dated August 22, 1963, recorded at Book 27, Eureka County Deeds at Page 12 in the Office of the County Recorder of Eureka County at Eureka, Nevada;

Together with all improvements thereon situated,


