

# CERTIFICATE OF LOCATION

Revised Laws, Sec. 2424

The Undersigned, hereby certifies that he has located a mining claim in the Eureka Mining District, County of Eureka, State of Nevada, on a vein or lode known as the JEWEL #4

The general course of said lode or vein, as near as it may be described, is North & South

The name of the locator is E. L. Cleveland, of 1201 Shadow Lane, Las Vegas, Nevada.

The said claim was located on the 14th day of August A. D. 1969, and is described in respect to Approximately 1200-lin. feet northwest of the Reservoir in New York Canyon.

The locator claim is 1500 feet in length

along the course of said vein or lode each way from the point of discovery with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

The dimensions and location of the discovery shaft work is A dozer excavation of the following approximate dimensions: 14.0 in width, 35' long, and 3.0 in depth.

The Northwest corner is marked by a 4" x 4" White Post 4' feet high inscribed N.W. corner of Jewel # 4 mine:  
the Northeast corner is marked by a 4" x 4" White Post 4' feet high inscribed Northeast corner of Jewel # 4 mine.  
The Southwest corner is marked by 4" x 4" White Post 4' feet high, inscribed S.W. Cor. corner Jewel # 4 mine: the Southeast corner is marked by a 4" x 4" White Post 4' feet high, inscribed S.E. Cor. corner Jewel # 4 mine. There is a White post of same size on each mid point as side center at each corner of each line. The discovery work has been done and the location work completed since October 1st A. D. 1969
