TO HAVE AND TO HOLD the said premises together with the appurtenances, unto the said part y of the second part, and to HIS heirs and assigns forever.

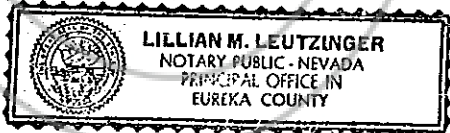
