THIS IS TO CERTIFY that the SILVER BOY #1 - R.R.C.

There is also a 4"X4" POST at the center of each side line. (Use reverse side for multiple locations.)

Each of the described monuments is a post at least 4 inches in diameter by 4 feet 6 inches in length set 1 foot in the ground.
