

A MAP SHOWING THE LOCATION AND POSITION OF THE SADIE GROUP OF CLAIMS IS ON THE LOCATION CERTIFICATE. EACH CLAIM IS 600 FEET WIDE AND 1500 FEET LONG.

SADIE # 7 - 1200 FEET FROM THE SOUTH END LINE AND 300 FEET FROM THE NORTH END LINE.

SADIE # 8 - 600 FEET FROM THE SOUTH END LINE AND 900 FEET FROM THE NORTH END LINE.

ALL MONUMENTS ARE POSTS 4 INCHES BY 4 FEET 6 INCHES LONG SET IN A MOUND OF STONE 2 FEET HIGH AND 4 FEET IN DIAMETER. EXCEPT THE SADIE # 3 WEST SIDE CENTER WHICH IS A STONE ATLEAST 6 INCHES IN DIAMETER BY 18 INCHES LONG SET IN A MOUND OF STONE 2 FEET HIGH AND 4 FEET IN DIAMETER.

THE SADIE # 1 DISCOVERY MONUMENT IS APPROX 1,050 FEET WESTERLY FROM THE MAIN SHAFT ON THE RAMBLER PATENT.
