

Certificate of Location of Lode Mining Claim

THIS IS TO CERTIFY that the Nov. 25, 1969 Lode Mining Claim was located by Z. Willaims, Jr., c/o Louis J. Monchuk, whose post office address appears below, on the day of 19.

The general course of said lode or vein is North & South.

The claim is situated in the S 4 E F A C T Mining District, EUREKA County, State of Nevada, Section N.E. - T. 31 N - R. 52 E

Borders N. End. Claim at S. E. End.

The locator's claim is 1500 feet in a NORTH direction and 0 feet in a SOUTH direction from the point of discovery, with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

The dimensions and locations of the discovery work done on the claim are as follows:

The corners and side centers of the claim are located and marked as follows:

From the N. W. corner, a monument marked 4 W 44 1/2 S 25 N. W. Cor., thence in a EAST direction 600 feet to the N. E. corner, a monument marked 4 W 44 1/2 N. E. Cor., thence 75.0 feet in a SOUTH direction to the EAST side center, a monument marked 4 W 44 1/2 S. E. SC, thence 75.0 feet in a SOUTH direction to the S. E. corner, a monument marked 4 W 44 1/2 S. E. Cor., thence 600 feet in a WEST direction to the S. W. corner, a monument marked 4 W 44 1/2 S. W. Cor., thence 75.0 feet in a NORTH direction to the West side center, a monument marked 4 W 44 1/2 N. W. SC, thence 75.0 feet NORTH to the point of beginning.

Each of the above-described monuments is 4 X 4 post.
