

(BY CORPORATION)

That the said party of the first part, in consideration of the sum of TENDOLLARS (\$10.00), lawful money of the United States of America, to it in hand paid by the said part ies—of the second part, the receipt whereof is hereby acknowledged, does by these presents grant, bargain and sell unto the said part ies—of the second part, and to their heirs and assigns forever, all that certain real property situate in the County of Eureka, State of Nevada, that is described as follows:

The N½ of NE½ of NW½ and the S½ of NE½ of NW¼ of Section 29, Township 29 North, Range 48 East, M.D.B.&M., as per Record of Survey Map recorded in Eureka County, State of Nevada, File No. 34550, Unit No. 5.

RESERVING, THEREFROM, an easement of 30' along all boundaries for ingress and egress, with power to dedicate, and, except any and all oil rights, including the right of entry for exploration and production of oil or other carbohydrates.

RESERVING, THEREFROM, a right of way, with right of entry upon, over, under, along, across, and through the said land for the purposes of erecting, constructing, operating, repairing and maintaining pole lines with cross arms for the transmission of electrical energy, and for telephone line, and/or for laying, repairing, operating and renewing any pipe line or lines for water, gas or sewerage, and any conduits for electric or telephone wires, and reserving the sale right to convey the rights hereby reserved.
