

## MEMORANDUM OF MINING LEASE

This memorandum of agreement entered into as of the 18 day of November, 1969, by and between LYLE F. CAMPBELL, a single man, whose address is P. O. Box 7377, Reno, Nevada 89502, and JULIAN E. SIMPSON and JEAN C. SIMPSON, husband and wife, whose address is P. O. Box 305, Corte Madera, California 94925 (hereinafter referred to as "Lessor", whether one or more), and OCCIDENTAL MINERALS CORPORATION, a Delaware corporation (hereinafter referred to as "Occidental").

In consideration of the terms and provisions set forth in that certain Mining Lease dated on even date herewith, (hereinafter called the "Agreement") between Lessor and Occidental, Lessor hereby leases to Occidental, and Occidental hereby leases from Lessor for an initial term of twenty (20) years and, at the election of Occidental for an additional term of forty (40) years thereafter, subject to the covenants, conditions, and provisions set forth in the Agreement, to each and all of which the parties hereby mutually agree, the certain unpatented lode mining claims situated in the Mt. Hope Area, county of Eureka, Nevada, and more particularly described in those certain instruments and agreements recorded in the official records of the Eureka County Recorder, Eureka County, Nevada, as listed on Exhibit A attached hereto and made a part hereof, as follows: Book 22, pages 386-419, February 19, 1968.

Also, under said Agreement, Lessor granted to Occidental an option to purchase the leased premises above described. This option may be exercised by Occidental while the Agreement remains in force and effect, subject to the terms and conditions of the Agreement.

The Agreement is by this reference incorporated herein and made a part hereof in all respects as though fully set forth herein.

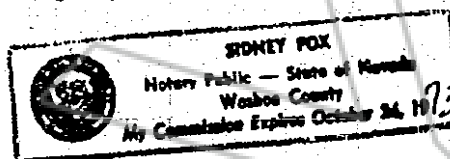
