

Certificate of Location of Lode Mining Claim

The locator's claim is 1500 feet in a SOUTH direction and 0 feet in a NORTH direction from the point of discovery, with a width of 300 FT. feet on each side of the center of the vein or lode along the entire length of said claim.

The dimensions and locations of the discovery work done on the claim are as follows: _____

400 FT. - 2 FT. x 10 FT. x 14 FT.

The total cost of such work consisted of at least \$ 100.00.

The corners and side centers of the claim are located and marked as follows:

From the N. West corner, a monument marked 4WAY #31 NW. Cor., thence in a EAST direction 600 feet to the N. EAST corner, a monument marked 4WAY #31 N.E. Cor., thence 750 feet in a SOUTH direction to the EAST side center, a monument marked 4WAY #31 E. SC, thence 750 feet in a SOUTH direction to the SOUTH EAST corner, a monument marked 4WAY #31 S.E. Cor., thence 600 feet in a WEST direction to the SOUTH WEST corner, a monument marked 4WAY #31 S.W. Cor., thence 750 feet in a NORTH direction to the WEST side center, a monument marked 4WAY #31 W. SC, thence 750 feet NORTH to the point of beginning.

Each of the above-described monuments is 17 post. 4x4.
