

AMENDED NOTICE OF LOCATION  
LODE MINING CLAIM

KNOW ALL MEN BY THESE PRESENTS, that the undersigned claims by right of discovery, the original Location and this Amended Location, and compliance with all of the requirements of law and local rules and customs, 1500 feet linear and horizontal measurement on this, named the GOLD STRIKE NO. 28 lode, along the vein thereof with all its dips, variations and angles; together with 300 feet linear and horizontal measurement in width on each side of the middle of said vein at the surface; and all veins, lodes, ledges, deposits and surface ground within the lines of said claim: 100 feet of said lode running due South and 1400 feet of said lode running due North from point of discovery, at which point of discovery a monument has been erected upon which this Notice is conspicuously posted.

Said claim is situated approximately 4610 feet in a N 30° 30' E direction from the Southeast corner, Section 30, Township 36 North, Range 50 East, M.D.B.M. in the Lynn Mining District, Eureka County, State of Nevada, and is bounded and particularly described as follows, to wit:

BEGINNING at Corner No. 1 (Southwest corner), thence N 00° E 750 feet to the W.S.C., thence N 00° E 750 feet to Corner No. 2, thence S 89° 51' E 600 feet to Corner No. 3, thence S 00° W 750 feet to the E.S.C., thence S 00° W 750 feet to Corner No. 4, thence N 89° 51' W 600 feet to Corner No. 1, the place of beginning.

Each of the corners of said claim is distinctly marked and defined by a monument so that the boundaries can be readily traced.

This Amended Notice of Location of the GOLD STRIKE NO. 28 lode mining claim, the original Certificate of Location of which was recorded in the records of Eureka County, Nevada, on April 19, 1963, in Book N, Page 159, is made for the purpose of appropriating all ground within the boundaries hereinbefore described, and correcting any irregularities, informalities, errors or defects which may have existed or do exist in the Original Location or the record thereof, hereby waiving no rights acquired under and by virtue of said Original Location. And if the Original Location is void, then this Amended Location shall be an original location and this amended notice of location an original notice of location.
