KNOW ALL MEN BY THESE PRESENTS, that the undersigned claims by right of discovery, the original Location and this Amended Location, and compliance with all of the requirements of law and local rules and customs, 1500 feet linear and horizontal measurement on this, named the GOLD STRIKE NO. 30 lode, along the vein thereof with all its dips, variations and angles; together with 300 feet linear and horizontal measurement in width on each side of the middle of said vein at the surface; and all veins, lodes, ledges, deposits and surface ground within the lines of said claim: 100 feet of said lode running due South and 1400 feet of said lode running due North from point of discovery, at which point of discovery a monument has been erected upon which this Notice is conspicuously posted.
