

AGREEMENT

BETWEEN:

NU-WEST OILS INC.

of the First Part;

and

SWISS OILS OF CANADA (1959) LTD.,

of the Second Part.

WHEREAS by an assignment of option in writing dated the 29th day of July, A.D. 1965 the Party of the First Part assigned to the Party of the Second Part its interests in certain mining leases in the Lynn Mining District of the Elko and Eureka Counties, Nevada, upon the terms and conditions in the said assignment contained.

AND WHEREAS the Party of the Second Part is in default in making payment of the consideration required under the said assignment of option.

AND WHEREAS the parties desire that the term within which payment might be made shall be extended.

NOW THEREFORE THIS AGREEMENT WITNESSETH that in consideration of the premises and the sum of One (\$1.00) Dollar now paid by the Party of the Second Part to the Party of the First Part, it is agreed as follows:

1. That the Party of the First Part does by these presents grant to the Party of the Second Part an extension of time in which the Party of the Second Part shall pay the consideration expressed in the said assignment of option until the first day of July, A.D. 1969 upon condition that the Party of the Second Part shall pay all rentals required.




