

GRANT, BARGAIN AND SALE DEED

THIS INDENTURE, made and entered into as of the 29th
 day of April, 1970, by and between FRED MINOLETTI and
 JULIA MINOLETTI, his wife, of the County of Eureka, State of
 Nevada, First Parties, and FRED MINOLETTI and JULIA MINOLETTI,
 his wife, of the same place, Second Parties,

W I T N E S S E T H:

That the said First Parties, for and in consideration
 of the sum of TEN DOLLARS (\$10.00), lawful money of the United
 States, to them in hand paid by the said Second Parties, and
 other good and valuable consideration, receipt whereof is hereby
 acknowledged, do by these presents grant, bargain, sell and
 convey unto the said Second Parties, as joint tenants with right
 of survivorship, and not as tenants in common, and to the assigns
 of said Second Parties, and to the survivor of them, and to the
 heirs, executors, administrators and assigns of the survivor,
 all that certain real property situate in the County of Eureka,
 State of Nevada, more particularly described as follows, to-wit:

PARCEL I

In Township 20 North, Range 53 East, MDR&M.

Section 32: SE $\frac{1}{4}$ NW $\frac{1}{4}$ and SW $\frac{1}{4}$ NE $\frac{1}{4}$

TOGETHER WITH all improvements situate thereon.

TOGETHER WITH all water, water rights, water
 applications and permits, and all dams, reservoirs,
 ditches, canals and other works for the storage,
 diversion or use of water, and all stockwatering
 rights appurtenant to or used or enjoyed in
 connection therewith; and together with all range
 rights and grazing rights owned by the First
 Parties, or used or enjoyed in connection with
 any of said property.

PARCEL II

In Township 20 North, Range 53 East, MDR&M.

Section 18: NE $\frac{1}{4}$; NW $\frac{1}{4}$; Lots 9 and 10, containing
 316.32 acres (sometimes referred to as

the E $\frac{1}{2}$ of Section 18).

TOGETHER WITH all improvements situate thereon.

TOGETHER WITH all water, water rights, water applications and permits, and all dams, reservoirs, ditches, canals and other works for the storage, diversion or use of water, and all stockwatering rights appurtenant to or used or enjoyed in connection therewith; and together with all range rights and grazing rights owned by the First Parties, or used or enjoyed in connection with any of said property.

PARCEL III

Lots 4, 5 and the N $\frac{1}{2}$ of Lot 6 in Block 31 of the Town of Eureka, making 62 $\frac{1}{2}$ feet in all, as shown by the Official Map of said Town of Eureka, Nevada,

TOGETHER WITH all improvements situate thereon.

PARCEL IV

All of Lots 1, 2 and 3 in Block 40 of the Town of Eureka, Nevada, as the same are described on the Official Plat of the Town of Eureka, on file in the office of the County Recorder of Eureka County, Nevada.

TOGETHER WITH all improvements situate thereon.

PARCEL V

Lot 1 in Block 32, and a strip of land 12 feet wide, fronting on Main Street and running thence West 90 feet, the same width, and which adjoins on the north the above-described Lot 1 in Block 32, the said 12 foot strip being a portion of the John E. Plater patent, Survey No. 95, all of which is laid down and delineated upon the U. S. Plat of the Survey of the Townsite of Eureka, Nevada, approved November 19, 1937. The said lands are described in the Official Map of the Town of Eureka, Nevada, filed in the Recorder's Office in the year 1881, identical with the above-description.

TOGETHER WITH all improvements situate thereon.

TOGETHER WITH the tenements, hereditaments and appurtenances belonging to or in anywise appertaining to the foregoing Parcels, and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.

TO HAVE AND TO HOLD, all and singular, the above described premises, together with the appurtenances, unto the said Second Parties, as joint tenants and not as tenants in

common, and to the survivor forever.
