CERTIFICATE OF LOCATION OF LODE CLAIM

THIS IS TO CERTIFY that the F-120 Lode Mining Claim was located by Idaho Mining Corporation on the 28th day of February, 1970. The general course of said vein or lode is easterly and westerly. The claim is situate in the Secret Canyon Area of the Eureka (unorganized) Mining District, Eureka County, Nevada.

The Locator claims 1490 feet in an easterly direction and 10 feet in a westerly direction from the location monument, and a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.
