

e CERTIFICATE OF LOCATION OF LODE CLAIM

F-128

THIS IS TO CERTIFY that the F-128 Lode Mining Claim was located by Idaho Mining Corporation on the 5th day of May, 1970. The general course of said vein or lode is easterly and westerly. The claim is situate in the Secret Canyon Area of the Eureka (unorganized) Mining District, Eureka County, Nevada.

The Locator claims 10 feet in an easterly direction and 1490 feet in a westerly direction from the location monument, and a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

In Compliance with Sections 517.040, 517.050 and other applicable portions of the Nevada Revised Statutes, the discovery work consisted of the excavation work listed below:

Bulldozer Cut:

12' x 80' x 4', situate 330' N 25 E from the SW Cor., F-128 claim.

Rotary Drill Hole:

F-11, situate 323' N 22° E from the SW Corner, F-128 claim.

This claim is one of a group of 6 contiguous claims, being the F-118, 120, 122, 124, 126 (relocated) and 128 (relocated), for whose benefit the discovery work described above was performed. More than \$600 was expended for drilling and excavations on said group of 6 claims, which did advance the exploration and development of all claims in said group.

Each corner or side center of said claim is marked with a 4" x 4" wooden post, 4½ feet long, set one foot of its length in the ground, said posts being located and marked (markings are on metal tags affixed to said posts) as follows (bearings and distances are approximate): "NW COR F-128"; thence easterly for a distance of 750' to a post marked, "NSC F-128"; thence easterly for a distance of 750' to a post marked, "NE COR F-128"; thence southerly for a distance of 600' to a post marked, "SE COR F-128"; thence westerly for a distance of 750' to a post marked, "SSC F-128"; thence westerly for a distance of 750' to a post marked, "SW COR F-128"; thence northerly for a distance of 600' to the point of beginning.

The Northwest corner of this claim is approximately 5,500 feet S 80° W from the northwest corner of Section 19, T. 18 N., R. 54 E., MDB&M.

This is a relocation of the claim previously located by Idaho Mining Corporation bearing the same name. The corners of the previous claim are hereby adopted.

All location and discovery work necessary to complete this location have been performed by May 20, 1970.
