CERTIFICATE OF LOCATION OF LODE CLAIM

THIS IS TO CERTIFY that the DOE RUN No. 1 Lode Mining Claim was located by John Damele and Owen Rice on the 28th day of February 1970. The general course of said vein or lode is easterly and westerly. The claim is situate in the Secret Canyon Area of the Eureka (unorganized) Mining District, Eureka County, Nevada.

The Locators claim 1490 feet in an easterly direction and 10 feet in a westerly direction from the location monument, and a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

In compliance with Sections 517.040, 517.050 and other applicable portions of the Nevada Revised Statutes, the discovery work consisted of the excavations listed below: A rotary hole was drilled at a location approximately 450' S 67° E of the North side center, Doe Run No. 2 claim. In addition, a drill site was prepared. This claim is one of a group of two contiguous claims, being the Doe Run Nos. 1 and 2, for whose benefit the discovery work described above was performed. More than \$200 was expended for said work on said claims, which did advance the exploration and development of each claim in said group.

Each corner and side center of said claim is marked with a 4" x 4" wooden post, 4½ feet long, set one foot of its length in the ground, said posts being located and marked (markings are on metal tags affixed to said posts) as follows (bearings and distances are approximate): "NW COR DOE RUN NO. 1"; thence easterly for a distance of 750' to a post marked, "NSC DOE RUN NO. 1"; thence easterly for a distance of 750' to a post marked, "NE COR DOE RUN NO. 1"; thence southerly for a distance of 600' to a post marked, "SE COR DOE RUN NO. 1"; thence westerly for a distance of 750' to a post marked, "SSC DOE RUN NO. 1"; thence westerly for a distance of 750' to a post marked, "SW COR DOE RUN NO. 1"; thence northerly, for a distance of 600' to the point of beginning.

The northwest corner of this claim is approximately 6,725 feet S 47.5° W from the northwest corner of Section 19, T. 18 N., R. 54 E., MDB&M.
