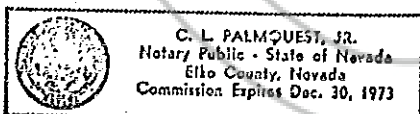
Know All Men By These Presents, that being first duly sworn, deposed and says;
