REPORT ON GEOCHEMICAL SURVEY, W-1, 2, 3, 4, 5, 7, 8, 12, 13
and 17 CLAIMS

A geochemical survey of the W-1 to W-5, W-7, W-8, W-12, W-13 and W-17 claims was conducted, starting in September 1969, and continuing through August 25, 1970. Soil samples were taken from the claims on 100 foot spacing, along east-west traverses 500 to 750 feet apart. The samples were dried and screened to -80 mesh, and the -80m fraction was analyzed for mercury and Heavy Metals (dithizone method).

In addition, rock chip samples from Drill Hole W-2, situate on the W-1 claim, were analyzed for mercury, Heavy Metals and also for copper, lead and zinc, to attempt to correlate the results of drilling with the soil sample survey. The work was done by W. L. Wilson, A. K. Wilson, Jr., Rocky Mountain Geochemical Labs. and Skyline Labs, Inc.

The basic findings from such survey were:

1. Broad mercury anomalies are present on the W-1, W-2, W-5, W-7 and W-8 claims, along the Hamburg dolomite-Secret Canyon shale contact. In the southern part of this claim group, the anomalous zone diverges from this contact and follows the middle portion of the Hamburg formation.
2. A zone, anomalous in Heavy Metals, generally follows the Hamburg dolomite outcrop on the W-2 and W-7 claims and on the W-3 and W-4 claims. This zone narrows to the south. This zone may be indicative of a generally higher base metals content in the Hamburg than in the surrounding rocks, although it does not encompass all of the Hamburg outcrop.
3. Drill hole W-2, situate in the northern portion of the W-1 claim, and in an area of anomalous Heavy Metals samples, contained anomalous values in base metals, principally zinc, with lesser amounts of lead and very low values in copper.
4. Little mercury was detected in the drill cuttings from drill hole W-2 in the intervals from 0 to 30 feet, however the amount of mercury increased below 30 feet.

This survey was non-repetitive of any previous known work, and did further the exploration and development of each claim in said group.

The writer, W. L. Wilson, who supervised the above survey, has been Exploration Manager for Idaho Mining Corporation for 11 years, and previous to that was employed in the mining and mineral exploration business for 6 years.
