

AMENDED LOCATION CERTIFICATE LODE CLAIM

This is to certify that the GILES No. 3 lode mining claim was located by M. S. Fisher, R. L. Taylor and Harry Treweek on the 28th day of March, 1959 and recorded June 26th, 1959, in Book "45" of Mining Locations on Page 320 in the Office of the Elko County Recorder, Elko, Nevada.

Notice is hereby given that the undersigned M. H. White, acting as agent for M. S. Fisher, R. L. Taylor and Harry Treweek as claimants of the said GILES No. 3 lode mining claim and preserving all rights under the said original location thereof does hereby amend the description of this claim, supplementing the information contained in the original certificate as recorded in the manner hereinafter set forth. The size, outline and field position of the claim remain as originally recorded.

The claim is situated in the Bootstrap Mining District, Elko and Eureka Counties, Nevada; its discovery monument is located S 2° 46' 32" W, a distance of 4765.07 feet from the corner common to Sections 2, 3, 10 and 11, Township 36 North, Range 49 East, Mount Diablo Base and Meridian.

The general course of the lode is N 16° 22' W and S 16° 22' E.

The claim extends 50 feet in a N 16° 22' W direction and 1450 feet in a S 16° 22' E direction from the discovery monument and 300 feet on each side of the center line of the lode along the full length of the claim.

The corners and side centers of this claim are located and marked as follows: Beginning at the northwest corner, a 4"x4"x5" wood post marked NW COR GILES NO 3; thence S 16° 22' E, 750 feet, west side center, a 4"x4"x5" wood post marked W S/C GILES NO 3, 1500 feet to the southwest corner, a 4"x4"x5" wood post marked SW COR GILES NO 3; thence N 73° 38' E, 600 feet to the southeast corner, a 4"x4"x5" wood post marked SE COR GILES NO 3; thence N 16° 22' W, 750 feet, east side center, a 4"x4"x5" wood post marked E S/C GILES NO 3, 1500 feet to the northeast corner, a 4"x4"x5" wood post marked NE COR GILES NO 3; thence S 73° 38' W, 600 feet to the northwest corner, the place of beginning.

The west side line of this claim is contiguous with the east side line of the El Ojo No. 4 claim; the south end line is contiguous with the north end line of the El Cerro No. 2 claim; the east side line is contiguous with the west side line of the Frances claim; the north end line is contiguous with the south end line of the Giles No. 2 claim;
