

AMENDED LOCATION CERTIFICATE LODE CLAIM

This is to certify that the EL VEGA No. 3 lode mining claim was located by Dale B. Trubey on the 28th day of July, 1963 and recorded October 24th, 1963, in Book "40" of Official Records on Page 469 in the Office of the Elko County Recorder, Elko, Nevada and recorded October 25th, 1963 in Book "P" of Outside Mining on Page 304 in the Office of the Eureka County Recorder, Eureka, Nevada and that subsequent thereto on April 11th, 1969 the said claim was assigned to Newmont Exploration Limited as recorded May 6th, 1969 in Book "109" of Official Records at Page 267 in the Office of the Elko County Recorder, Elko, Nevada and recorded May 7th, 1969 in Book "29" of Official Records at Page 43 in the Office of the Eureka County Recorder, Eureka, Nevada.

Notice is hereby given that the undersigned Newmont Exploration Limited as assignee and claimant of the said EL VEGA No. 3 lode mining claim and preserving all rights under the said original thereof does hereby amend the description of this claim, supplementing the information contained in the original certificate as recorded in the manner hereinafter set forth. The size, outline and field position of the claim remain as originally recorded.

The claim is situated in the Bootstrap Mining District, Elko and Eureka Counties, Nevada; its discovery monument is located S 26° 54' 19" E, a distance of 4578.84 feet from the corner common to Sections 2, 3, 10 and 11, Township 36 North, Range 49 East, Mount Diablo Base and Meridian.

The general course of the lode is N 16° 22' W and S 16° 22' E.

The claim extends 50 feet in a N 16° 22' W direction and 1450 feet in a S 16° 22' E direction from the discovery monument and 300 feet on each side of the center line of the lode along the full length of the claim.

The corners and side centers at this claim are located and marked as follows: Beginning at the northwest corner a 4"x4"x5' wood post marked NW COR EL VEGA NO 3; thence S 16° 22' E, 750 feet, west side center, a 4"x4"x5' wood post marked W S/C EL VEGA NO 3, 1500 feet to the southwest corner, a 4"x4"x5' wood post marked SW COR EL VEGA NO 3; thence N 73° 38' E, 600 feet to the southeast corner, a 4"x4"x5' wood post marked SE COR EL VEGA NO 3; thence

N 16° 22' N, 750 feet, east side center; a 4"x4"x5' wood post marked E S/C EL VEGA NO 3, 1500 feet to the northeast corner, a 4"x4"x5' wood post marked NE COR EL VEGA NO 3; thence S 73° 38' W, 600 feet to the northwest corner, the place of beginning.

The west side line of this claim is contiguous with the east side line of the El Vega No. 2 Claim; the east side line is contiguous with the west side line of the El Vega No. 4 claim; the north end line is contiguous with the south end line of the Boulder Cap No. 10 claim.
