Such work or improvements, and character, consisted of geological and geochemical surveys, including trace element determinations in rock outcrops, soils, drainages sediments, along high angle faults, thrust faults, intrusive bodies, jasperoid dikes and areas of grabens. Such surveys were conducted on J-5, Del Nos. 4, 23, 26, 44, 49, 50, 59, 61 and on Prado Nos. 1, 2, 3, 4, 5, 7, 9, 11 and 26 and at various other sites on the claims, and aggregated in excess of \$ 3,600 on the 36 J, Del and Prado claims for the benefit of all of the claims, all of which are contiguous. The surveys disclosed element anomalies reflecting hydrothermal metalization. Surveys were conducted by Julian E. Simpson, Engineer of Mines, and by other persons and corporations. Maps have been prepared reflecting data obtained by surveys.
