

# Certificate of Location of Lode Mining Claim

THIS IS TO CERTIFY that the Gray Canyon #7 Lode Mining Claim was located by John V. Dangle and Willis A. DePaoli, whose post office address appears below, on the 9th day of October, 1970.

The general course of said lode or vein is Northerly and Southerly

The claim is situated in the Unknown Mining District, Eureka County, State of Nevada, lead is approx. 5 miles south of Prospect Peak, and 1 mile north of South Hill. The west side line of this claim is common with the east side line of Gray Canyon #8 claim.

The locator, 8 claim 1475 feet in a southerly direction and 25 feet in a northerly direction from the point of discovery, with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

The dimensions and locations of the discovery work done on the claim are as follows:

A Cat cut at least 14 feet wide by 20 feet long by 2 feet deep and situated about 90 feet south<sup>EAST</sup> from the northwest corner of this claim

The total cost of such work consisted of at least \$ 100.00

The corners and slit centers of the claim are located and marked as follows:

From the Northwest corner, a monument marked N.W. Cor., thence in a easterly direction 600 feet to the NorthEast corner, a monument marked N.E. Cor., thence 750 feet in a southerly direction to the east side center, a monument marked E.S.C. SC, thence 750 feet in a southerly direction to the southeast corner, a monument marked S.E. Cor., thence 600 feet in a westerly direction to the southwest corner, a monument marked S.W. Cor., thence 750 feet in a northerly direction to the west side center, a monument marked W.S.C. SC, thence 750 feet northerly to the point of beginning.

Each of the above-described monuments is a wooden post, 3" x 4" x 4" high
