

Certificate of Location of Lode Claim

The dimensions and locations of the discovery work done on the claim are as follows:

EVON #4 IS ONE OF FIVE CONTIGUOUS CLAIMS TO WIT: EVON 1, 2, 3, 4 AND 5. FIVE HOLES WERE DRILLED, LOCATED AS FOLLOWS: DRILL HOLE #1 IS APPROX S 71° W ABOUT 200' FROM THE LOCATION MONUMENT OF EVON #4; DRILL HOLE #2 IS APPROX S 82° W ABOUT 820' FROM THE N.E. CORNER OF EVON #5; DRILL HOLE #3 IS APPROX N 88° E ABOUT 48' FROM THE N.S. CENTER OF EVON #5; DRILL HOLE #4 IS APPROX N 80° E ABOUT 300' FROM THE S.W. CORNER OF EVON #5; DRILL HOLE #5 IS APPROX N 83° W ABOUT 145' FROM THE N.E. CORNER OF EVON #4. THESE FIVE DRILL HOLES ARE IN EXCESS OF 4 1/2" IN DIAMETER. THE TOTAL FOOTAGE DRILLED WAS 400'.

The total cost of such work consisted of at least \$ 17.00

The corners and side center of the claim are located and marked as follows: FROM A POST MARKED S.E. CORNER EVON #4, THENCE 750' WESTERLY TO A POST MARKED S.S. CENTER EVON #4, THENCE 750' WESTERLY TO A POST MARKED S.W. CORNER EVON #4, THENCE 600' NORTHERLY TO A POST MARKED N.W. CORNER EVON #4, THENCE 750' EASTERLY TO A POST MARKED N.S. CENTER EVON #4, THENCE 750' EASTERLY TO A POST MARKED N.E. CORNER EVON #4, THENCE 600' SOUTHERLY TO A POST MARKED S.E. CORNER, WHICH WAS THE POINT OF DISCOVERY. THE LOCATION MONUMENT IS APPROX N 04° W ABOUT 900' FROM THE S.E. CORNER OF SEC. 10. THE SOUTH SIDE LINE IS CONTIGUOUS WITH THE NORTH SIDE LINE OF EVON #5 AND THE EAST END LINE IS CONTIGUOUS WITH THE EAST SIDE LINE OF SECTION 10.
