## AGREEMENT

THIS AGREEMENT made this 16th day of July, 1970, by and between LYLE F. CAMPBELL of Reno, Nevada, U.S.A., hereinafter referred to as Campbell, of the first part, and AMERICAN SELCO INCORPORATED, a company incorporated under the laws of the State of New York, U.S.A. and having its offices at 210 Clayton Street, Denver, Colorado, U.S.A., hereinafter referred to as Selco, of the second part.

## WITNESSETH

That in consideration of the payment of Five Dollars (\$5.00) paid by each party to the other, receipt whereof is acknowledged by each of the parties hereto, and for good and sufficient other consideration:

1. Campbell has made and entered into an agreement with Selco dated July 16, 1970 pursuant to which agreement Campbell has granted to Selco until July 31, 1973 the sole exclusive and immediate right to enter upon, explore, examine, prospect, investigate, develop and to have quiet and exclusive possession of those unpatented mining claims listed in this clause (1), held by Campbell and situate in Eureka County, State of Nevada:
