BOUNDARIES OF EUREKA COUNTY

Boundaries of Eureka County as established by an Act of Nevada Legislature, 1873, as re-defined by the Nevada Legislature in 1873, 1877 and 1881, being reflected in the present NRS 243. 110, 243. 115 and 243. 120 respectively and Chapter 387, Statutes of Nevada 1969, as follows:

The boundary line between Eureka and Lander counties is hereby defined and established as follows: Beginning at a point on the east boundary of section 18, T. 36 N., R. 48E., at the intersection of the east boundary of section 18 and the Elko County line; thence southerly along the east boundary of sections 18, 19, 30 and 31 of T. 36N., R. 48E., to the southeast corner of section 31; thence westerly along the south boundary of section 31 to the NW corner of section 5, T. 35N., R. 48E.; thence southerly along the west boundary of sections 5, 8, 17, 20, 29 and 32, T. 35N., R. 48E., to the SW corner of section 32; thence westerly along the north boundary of section 5, T. 34N., R. 48E., to the NW corner of section 5; thence southerly along the west boundary of sections 5, 8, 17, 20, 29 and 32 of T. 34N., R. 48E., to the SW corner of section 32; thence continuing southerly along the west boundary of sections 5, 8, 17, 20, 29 and 32, T. 33N., R. 48E., to the SW corner of section 32; thence westerly along the north boundary of section 5, T. 32N., R. 48E., to the NW corner of section 5; thence southerly along the west boundary of sections 5, 8, 17, 20, 29 and 32, T. 32N., R. 48E., to the SW corner of section 32; thence continuing southerly along the west boundary of sections 5, 8, 17, 20, 29 and 32, T. 31N., R. 48E., to the SW corner of section 32; thence easterly along the south boundary of section 32 to the NW corner of section 5, T. 30N., R. 48E.; thence southerly along the west boundary of sections 5, 8, 17, 20, 29 and 32, T. 30N., R. 48E., to the SW corner of section 32; thence easterly along the south boundary of section 32 to the NW corner of section 5, T. 29N., R. 48E.; thence southerly along the west boundary of sections 5, 8, 17, 20, 29 and 32, T. 29N., R. 48E., to the SW corner of section 32; thence continuing southerly along the west boundary of sections 5, 8, 17, 20, 29 and 32, T. 28N., R. 48E., to the SW corner of section 32; thence continuing southerly along the west boundary of sections 5, 8, 17, 20, 29 and 32, T. 27N., R. 48E., to the SW corner of section 32; thence continuing southerly along the west boundary of sections 5, 8, 17, 20, 29 and 32, T. 26N., R. 48E., to the SW corner of section 32; thence easterly along the south boundary of section 32 to the

NW corner of section 4, T. 25N., R. 48E.; thence southerly along the west boundary of sections 4, 9, 16, 21, 28 and 33, T. 25N., R. 48E., to the SW corner of section 33; thence continuing southerly along the west line of sections 4, 9, 16, 21, 28 and 33, T. 24N., R. 48E., to the SW corner of section 33; thence continuing southerly along the west boundary of sections 4, 9, 16, 21, 28 and 33, T. 23N., R. 48E., to the SW corner of section 33; thence continuing southerly along the west boundary of sections 4, 9, 16, 21, 28 and 33, T. 22N., R. 48E., to the SW corner of section 33; thence continuing southerly along the west boundary of sections 4, 9, 16, 21, 28 and 33, T. 21N., R. 48E., to the SW corner of section 33; thence westerly along the south boundary of section 32, T. 21N., R. 48E., to the N $\frac{1}{4}$ corner of section 5, T. 20N., R. 48E.; thence southerly along the north-south $\frac{1}{4}$ section line of sections 5, 8, 17, 20, 29 and 32, T. 20N., R. 48E., to the S $\frac{1}{4}$ corner of section 32; thence continuing along the north-south $\frac{1}{4}$ section line of sections 5, 8, 17, 20, 29 and 32, T. 19N., R. 48E., to the S $\frac{1}{4}$ corner of section 32; thence continuing southerly along the north-south $\frac{1}{4}$ section line of sections 5, 8, 17, 20, 29 and 32, T. 18N., R. 48E., to the S $\frac{1}{4}$ corner of section 32; thence westerly along the south boundary of section 32 to the NW corner of section 5, T. 17 $\frac{1}{2}$ N., R. 48E., (unsurveyed); thence southerly along the west boundary of sections 5 and 8, T. 17 $\frac{1}{2}$ N., R. 48E., (unsurveyed), to the SW corner of section 8; thence continuing southerly along the west boundary of sections 5, 8, 17, 20, 29 and 32, T. 17N., R. 48E., (unsurveyed), to the SW corner of section 32; thence continuing southerly along the west boundary of sections 5, 8, 17, 20, 29 and 32, T. 16N., R. 48E., to the SW corner of section 32; thence westerly along the south boundary of section 31, T. 16N., R. 48E., to the NW corner of section 5, T. 15N., R. 48E.; thence southerly along the west boundary of section 5 to its intersection with the Nye County line. All township and range references are to the Mount Diablo Base and Meridian.

Thence easterly along the northern boundary of Nye County to its intersection with White Pine County; thence northerly along the western boundary of White Pine County to a point in section 5, township 18 north, range 54 east, as set out in NRS 243. 120; then continuing northward along the summits of the Diamond Range of mountains as described in NRS 243. 120 (formerly Statutes of 1881),

to the southern boundary of Elko County; thence westerly along the southern boundary of Elko County to a point on the northern line of section 21, township 26 north, range 53 east, on the 116th meridian as described in NRS 243.115 (Statutes of 1887 and 1892); thence northwesterly along the western boundary of Elko County to a point on the southeast corner of section 7, township 32 north, range 52 east, as described in NRS 243.115, near the intersection of 40 degrees 40 minutes of north latitude on the eastern boundary of said section; thence northerly along the western boundary of Elko County to a point in section 17, township 36 north, range 52 east, as described in NRS 243.115. then proceeding westerly along the southern boundary of Elko County to the aforesaid point of beginning.


