CERTIFICATE OF LOCATION

THE UNDERSIGNED, hereby certifies that he has located a mining claim in the County of EUREKA, State of Nevada, on a vein or lode known as the MAGGIE CREEK # 45.

The name of the locator is G. Eldon Roberts whose post office address is: Box 28, Riverton, Utah 84065.

The said claim was located on the 17th day of May 1971.

The locator claims 1330 linear feet in length in a north-south direction along the course of said vein or lode running 1305 feet southerly and 25 feet northerly, from the point of discovery at which this location certificate is posted, with a width of 300 linear feet on each side of the center of the vein or lode along the entire length of said claim.

The metes and bounds description of the claim, by reference to an official corner of the Public Land Survey, is as follows:

Within Section 14, Township 34 North, Range 51 East, M.D.B.&M., and from the southeast corner of Section 14, Township 34 North, Range 51 East, M.D.B.&M., bear North for 1330 feet and West for 2400 feet to the northeast corner, or Corner No. 1, of the claim, marked by a post 4 inches in diameter and 4 1/2 feet in length with the markings thereon.

Thence 600 feet in a West direction to Corner No. 2 marked by a post 4 inches in diameter and 4 1/2 feet in length, with the markings thereon.

Thence 665 feet in a south direction to Corner No. 3 marked by a post 4 inches in diameter and 4 1/2 feet in length, with the markings thereon.

Thence 665 feet in a south direction to Corner No. 4 marked by a post 4 inches in diameter and 4 1/2 feet in length, with the markings thereon.

Thence 600 feet in a East direction to Corner No. 5 marked by a post 4 inches in diameter and 4 1/2 feet in length with the markings thereon.

Thence ⁶⁶⁵~~310~~ feet in a north direction to Corner No. 6 marked by a post 4 inches in diameter and 4 1/2 feet in length, with the markings thereon.

Thence ⁶⁶⁵~~310~~ feet in a north direction to the point of beginning.

The location work consisted of making the map as provided in NRS 517.040.
