

AMENDMENT TO MINING LEASE AND PURCHASE AGREEMENT

THIS AMENDMENT TO MINING LEASE AND PURCHASE AGREEMENT is entered into this 30th day of January, 1971, for the purpose of amending Mining Lease and Purchase Agreement dated November 27, 1970, by and between JACK L. BAY and GENEVA R. BAY, Lessors, and WILLIAM E. GERGEN, Lessee, covering the unpatented mining claims known as Edith Ohlin #1, Edith Ohlin #2, Edith Ohlin #3, Edith Ohlin #4, Sharer and Sharer #1, and

WHEREAS, Lessors and Lessee do hereby change and amend Paragraph 5, Page 2, last line of the first paragraph to read as follows:

"All payments shall be deposited to the account of Lessor in the FIRST AMERICAN TITLE COMPANY OF NEVADA, Security National Bank Bldg., Carson City, Nevada."

Lessor and Lessee do hereby change and amend Paragraph 5, Page 2, Subsection "D", last line, to read as follows:

"All payments shall be paid for the account of Lessor at the FIRST AMERICAN TITLE COMPANY OF NEVADA, Security National Bank Bldg., Carson City, Nevada."

Lessor and Lessee do hereby change and amend Paragraph 13, Page 3, Sentence 4 to read as follows:

"It is agreed that as of this date the lease is signed Lessors shall execute a good and sufficient Quitclaim Deed for unpatented claims to said properties and have same placed in escrow in FIRST AMERICAN TITLE COMPANY OF NEVADA, together with the original of this agreement with instructions for the Deed to be delivered together with the original contract and any other papers involved to Lessee upon the payment and performance of the contract as herein stated."
