I, LEROY LLOYD MEYER, of 5700 Park Oaks Drive, Carmichael, California, being of sound and disposing mind and memory, and not acting under duress, menace, fraud or undue influence of any person or persons whomsoever, do make, publish, and declare this to be my Last Will and Testament.

FIRST: I hereby revoke all former Wills and Codicils to Wills heretofore made by me.

SECOND: I hereby direct my Executrix to pay and discharge all my just debts and funeral expenses promptly from the principal of my estate.

THIRD: I do hereby give, devise and bequeath all of the rest, residue and remainder of my estate of whatever description and wheresoever located to EUNICE MACHACEK and LA VERNE MACHACEK of Diamond Valley, Nevada, or to the survivor of them, in trust, in equal shares, for my two children, to wit: LORI MARGUERITE MEYER, born October 6, 1960, and LEAH ANN MEYER, born December 30, 1967.

As each of my said children shall attain the age of twenty one years, this trust, at this time, and as to each said child, shall terminate, and as soon thereafter as is practicable, my trustee or trustees shall distribute to each said child this portion of the corpus and income of the trust estate as shall be equivalent to fifty per cent (50%) of the then total trust estate.

In the event that the said trustees should both predecease me, or should both die during the minority of my said children, or either of them, I do hereby nominate and appoint BERNARD MURPHY and MARILYN MURPHY of 6336 Edgerton, Carmichael, California, or the survivor of them to act as trustee or trustees as aforesaid.

FOURTH: I do hereby nominate and appoint my sister, HULDA WESTERKAMP of Sunrise Mobile Home Estates, Fair Oaks, California, as Executrix hereof, without bond.

FIFTH: I do hereby nominate and appoint my sister and brother-in-law, EUNICE MACHACEK and LA VERNE MACHACEK, or the survivor of them, as guardians of the persons and estates of any child, or children, of mine who is a minor as of the date of my demise.

In the event that the said EUNICE MACHACEK and LA VERNE MACHACEK should predecease me or for any reason be unable to act as guardian of the person and estate of my minor child, or children, as the case may be, I do then appoint BERNARD MURPHY and MARILYN MURPHY to act as guardians of the person and estate of any child, or children, of mine who is a minor as of the date of my demise.

SIXTH: I have purposely made no provisions for any other person, whether claiming to be an heir of mine or not, specifically including, but not limited to, my wife, FRANCES ANN MEYER, who is now suffering a terminal illness, and if any person, whether a beneficiary under this Will or not mentioned herein, shall contest this Will or object to any provisions herein, I give to such person so contesting or objecting the sum of ONE DOLLAR (\$1.00) and no more, in lieu of the provisions which I have made or which I might have made herein for such person so contesting.
