

RELOCATION LOCATION CERTIFICATE

This is to certify that the SEVY No. 11 lode mining claim was located by M. H. White on the 28th day of July 1971. XXXXXXXXXXXXXXXX

The general course of said vein or lode, as near as it may be described is N. 87° 23' 47" E. and S. 87° 23' 47" W.

The claim is situated in the Secret Canyon mining district, Eureka County, State of Nevada, and the discovery monument is located S 30° 58' 58" E, 17,182.963 feet from the southeast corner of Section 34, T. 19 N.; R. 53 E.; M.D.B. & M., and lies in Sections 16 & 21, T. 18 N.; R. 53 E.; M.D.B. & M., Unsurveyed.

The locator claims 100 feet in a S. 87° 23' 47" W. direction and 1350 feet in a N. 87° 23' 47" E. direction from the point of discovery, with a width of 290 feet on each side of the center of the vein or lode along the entire length of said claim.

Beginning at the northwest corner, a 4"x4"x4 1/2" wood post marked N.W. corner 2, Sevy 11; thence N. 87° 23' 47" E., 725 feet, north side center, a 4"x4"x4 1/2" wood post marked N. side center, 3, Sevy 11, 1450 feet to the N.E. corner, a 4"x4"x4 1/2" wood post marked N.E. corner 4, Sevy 11; thence S. 2° 36' 13" E., 580 feet to the southeast corner, a 4"x4"x4 1/2" wood post marked S.E. corner 5, Sevy 11; thence S. 87° 23' 47" W., 725 feet, south side center, a 4"x4"x4 1/2" wood post marked S. side center, 6, Sevy 11, 1450 feet to the S.W. corner, a 4"x4"x4 1/2" wood post marked S.W. corner 1, Sevy 11; thence N. 2° 36' 13" W., 580 feet to the northwest corner, the place of beginning.

The north side line of this claim is contiguous with the south side line of the Sevy 10 claim; the west end line is contiguous with the east end line of the Sevy 63 claim; the south side line is contiguous with the north side line of the Sevy 12 claim; the end line is contiguous with the end line of the claim.
