

LOCATION CERTIFICATE

This is to certify that the SEVY No. 65 lode mining claim was located by M. H. White on the 27th day of July 1971.

The general course of said vein or lode, as near as it may be described is N. 87° 23' 47" E. and S. 87° 23' 47" W.

The claim is situated in the Secret Canyon mining district, Eureka County, State of Nevada, and the discovery monument is located S. 42° 29' 19" W. 13,703.621 feet from the southeast corner Section 4 approximately T. 19 N.; R. 53 E.; M.D.B. & M. and lies in Section 16; 18 N.; R. 53 E.; M.D.B. & M. UNSURVEYED.

The locator claims 100 feet in a N. 87° 23' 47" E. direction and 1350 feet in a S. 87° 23' 47" W. direction from the point of discovery, with a width of 290 feet on each side of the center of the vein or lode along the entire length of said claim.

The corners and side centers of this claim are located and marked as follows: Beginning at the northwest corner, a 4"x4"x4 1/2' wood post marked N.W. corner 2, Sevy. 65; thence N. 87° 23' 47" E., 725 feet, north side center, a 4"x4"x4 1/2' wood post marked N. side center, 3, Sevy. 65, 1450 feet to the N.E. corner, a 4"x4"x4 1/2' wood post marked N.E. corner 4, Sevy. 65; thence S. 2° 36' 13" E., 580 feet to the southeast corner, a 4"x4"x4 1/2' wood post marked S.E. corner 5, Sevy. 65; thence S. 87° 23' 47" W., 725 feet, south side center, a 4"x4"x4 1/2' wood post marked S. side center, 6, Sevy. 65, 1450 feet to the S.W. corner, a 4"x4"x4 1/2' wood post marked S.W. corner 1, Sevy. 65; thence N. 2° 36' 13" W., 580 feet to the northwest corner, the place of beginning.

The north side line of this claim is contiguous with the south side line of the Sevy. 66 claim; the east end line is contiguous with the west end line of the Sevy. 3 claim; the south side line is contiguous with the north side line of the Sevy. 64 claim; the end line is contiguous with the end line of the claim.

All location work necessary to complete this location had been performed by October 11, 1971.
