AMENDED LOCATION CERTIFICATE

THIS IS TO CERTIFY that a mining claim named the No. 11 was located by ALLEN RUSSELL of Mill Canyon, Eureka County, Nevada, P. O. Box 648, Beowawe, Nevada 89821, a citizen of the United States, on the 19th day of August, 1954, situated in the Cortez Mining District, Eureka County, Nevada, State of Nevada, being contiguous to the Victory Lode Mining Claim; the southwest corner of said No. 11 Lode Mining Claim being a steel post, common to the southeast corner of the Victory Lode Mining Claim, lying north 74° 31 Min. 30 Sec. east of the southwest corner of the Victory Lode Mining Claim from which the brass cap section corner common to sections 1, 6, 7, and 12 of Township 26N, R48 E MDB&M bears south 12° 19 Min. west a distance of approximately 19268.9 feet.

We claim 1500 linear feet along the course of a mineral bearing ledge, lode or vein, extending 750 feet from the location monument in the westerly direction and 750 feet in an easterly direction together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The discovery work consists of an open cut situated about 130 feet in a westerly direction from the location monument and its dimensions are more than 7 feet wide 10 feet long and 4 feet deep, exposing ledge, lode or vein in place, and was completed on September 30, 1954.

Each corner and side of said lode mining claim is marked as follows, to-wit:

The northwest corner is marked by a steel post which is common to the Victory Lode Mining Claim
