Such work or improvements consisted of preparing haulage roads, trenching, preparing access roads and drill sites, removal of overburden to develop ore, the mining of ore for metallurgical testing, and the drilling of 3 rotary drill holes a total footage of 600 feet.

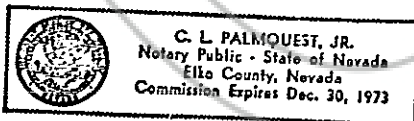
