GROTH, his wife, as Joint Tenants, all of the rights, title and interest of the Government (except such interests as may have been reserved in patents issued by the Government) in and to the following described real property situated in the County of Eureka, State of Nevada:

Section 2: Lots 5 & 6; S 1/2 NW 1/4; SW 1/4

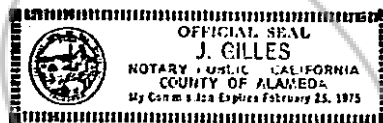
