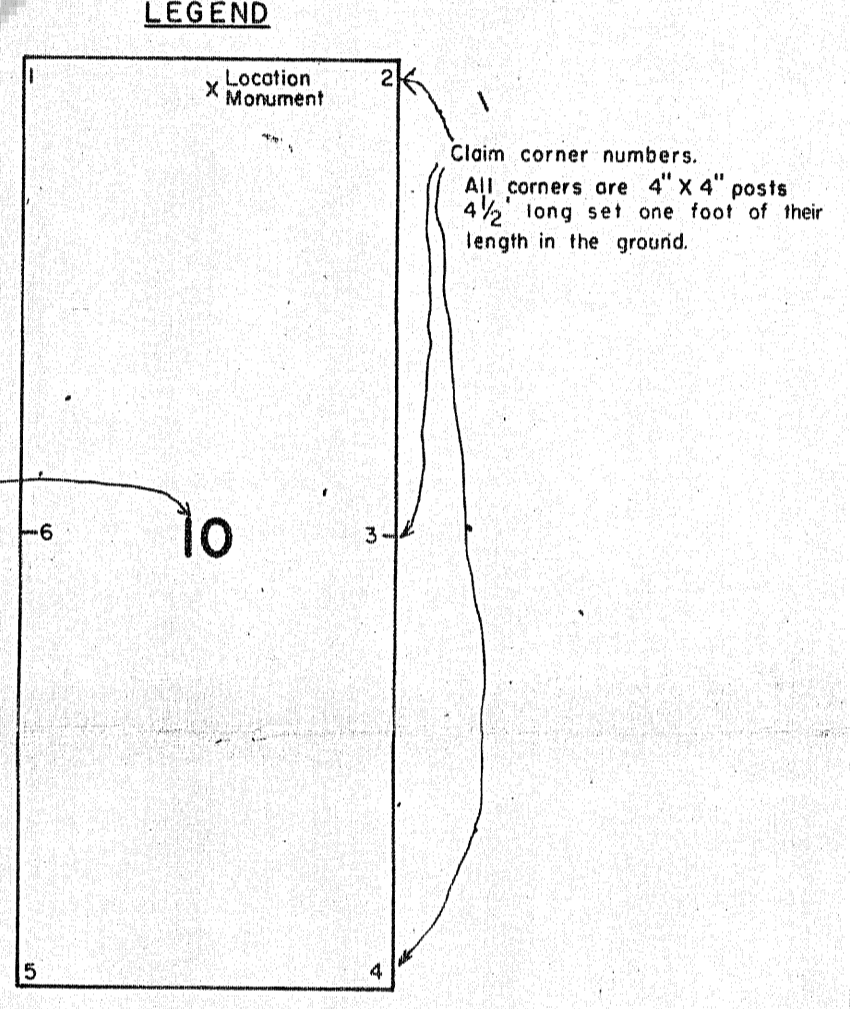
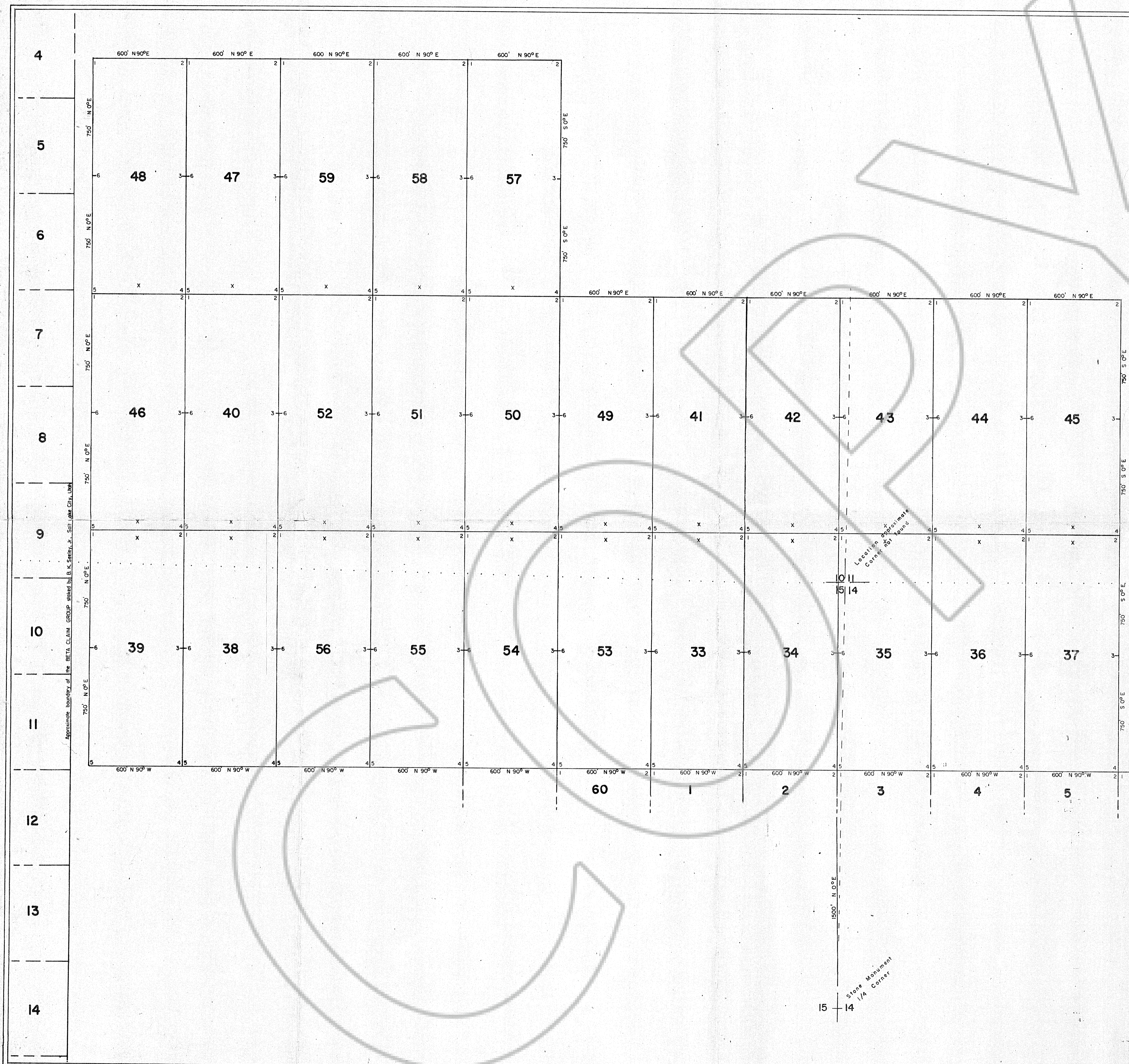


MAP OF THE ACE LODE CLAIM GROUP

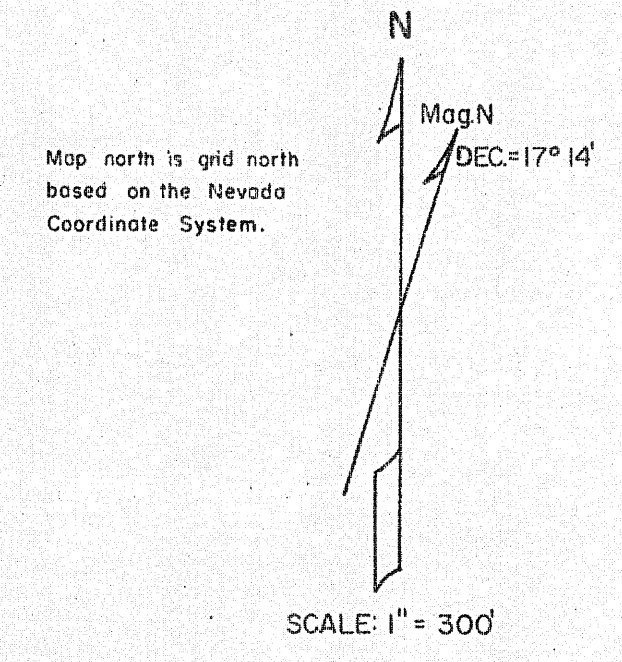
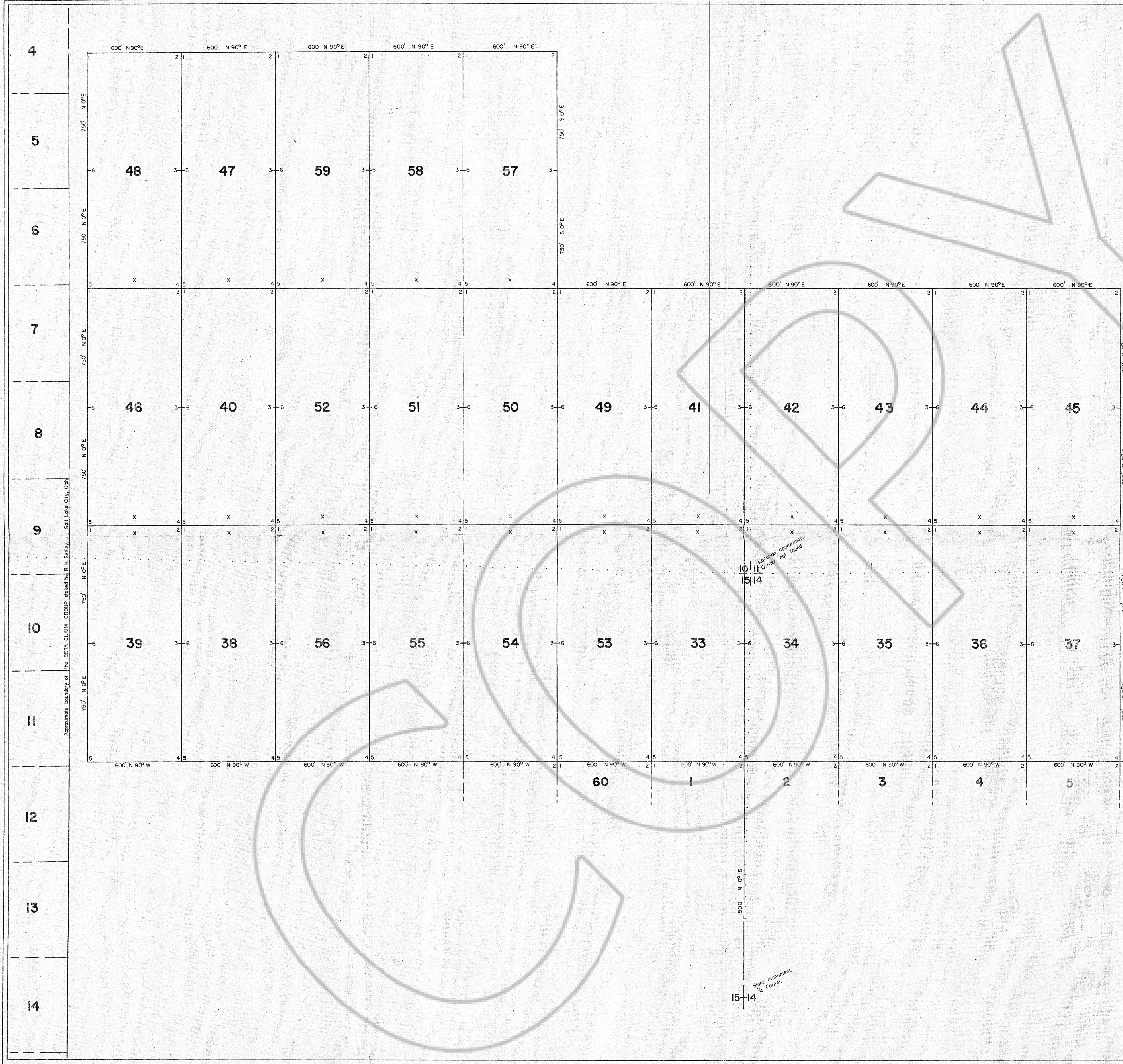

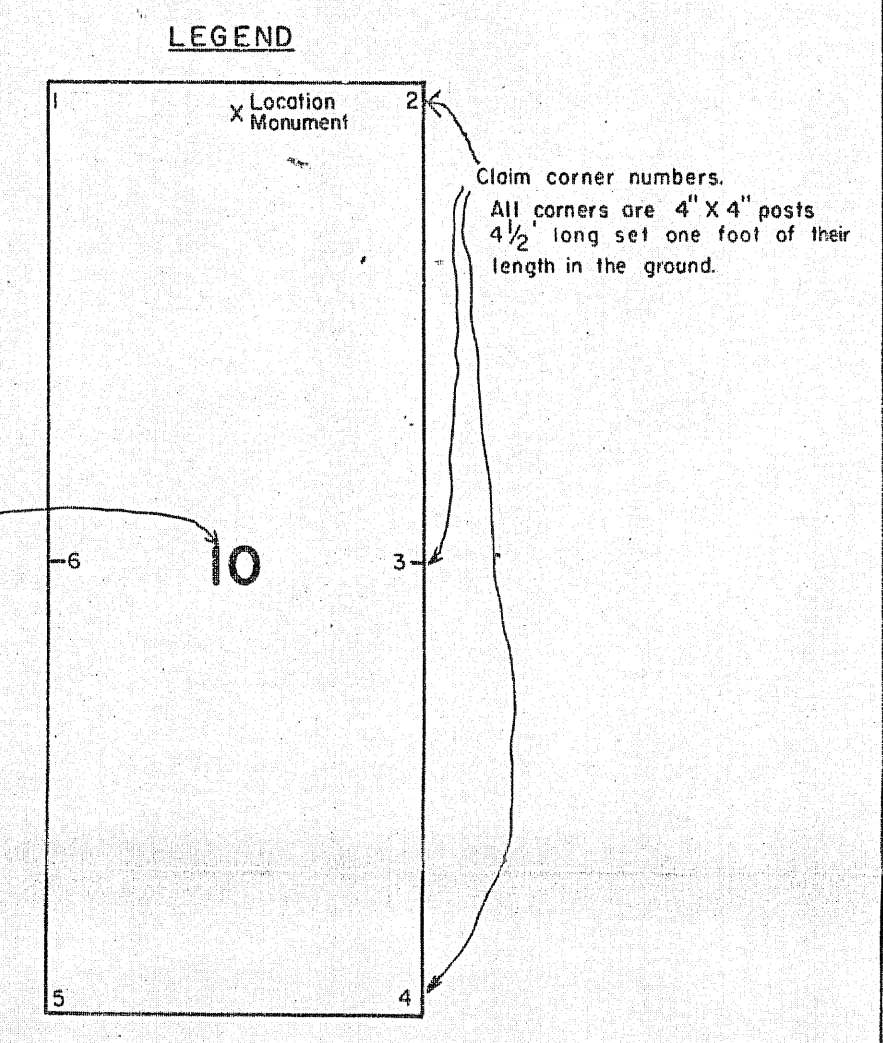
