1 THIS DEED OF TRUST, made this 8 day of May, A.D.,  
2 1972, between FRED SPRACKLIN and MILDRED L. SPRACKLIN, husband and  
3 wife, of the county of Churchill, state of Nevada, hereinafter  
4 called the trustors, and TITLE SERVICE & ESCROW CO., a corporation,  
5 hereinafter called the trustee, and JOHN BORGNA, an unmarried man,  
6 of the county of Eureka, state of Nevada, hereinafter called the  
7 beneficiary,

8 W I T N E S S E T H :

9 WHEREAS, the trustors are indebted to the beneficiary in  
10 the sum of TWENTY-FIVE HUNDRED DOLLARS (\$2,500.00) and have agreed  
11 to pay the same with interest thereon at the rate of SIX and  
12 ONE-HALF PER CENT (6 1/2%) per annum, according to the terms of a  
13 certain promissory note of even date herewith, executed and de-  
14 livered by the trustors to the beneficiary; and

15 WHEREAS, this deed of trust is intended to secure the  
16 payment of said promissory note, which promissory note represents  
17 money actually used for the acquisition of the property described  
18 herein;

19 NOW, THEREFORE, the trustors, for the purpose of secur-  
20 ing the payment of the principal and interest of said promissory  
21 note, and the other amounts set forth therein, and also of all  
22 other moneys herein agreed or provided to be paid by the trustors,  
23 or either of them, or which may be paid out or advanced by the  
24 beneficiary, or the trustee, under the provisions of this instru-  
25 ment, with the interest in each case, grant unto the trustee all  
26 that certain lot, piece or parcel of land, situate in the Town of  
27 Eureka, State of Nevada, more particularly described as follows,  
28 to wit:

29 All of LOT ONE (1) in BLOCK FIFTY-SIX (56) of the  
30 Town of Eureka, Nevada, together with the frame house  
shed, furniture and equipment located therein.

1 TOGETHER with, all and singular, the tenements, heredita-  
2 ments and appurtenances thereunto belonging, or in anywise apper-  
3 taining, and the reversions and reversions, remainder and remainders,  
4 rents, issues and profits thereof.

5 This deed of trust will be security for the payment, in  
6 lawful money of the United States, of any and all moneys that may  
7 hereafter become due and payable from the trustors, or either of  
8 them, to the beneficiary, from any cause whatsoever, and shall  
9 also be security for any and all renewals of the debt of the  
10 trustors to the beneficiary, however evidenced.

11 The following covenants: Numbers 1, 2 \$2,500.00,  
12 3, 4 7%, 5, 6, 7 REASONABLE, 8 and 9 of Nevada Revised Statutes,  
13 Section 1 07.030, relating to transfers in trust of estates in  
14 real property to secure the performance of an obligation or the  
15 payments of a debt, and to provide that certain covenants, agree-  
16 ments, obligations, rights and remedies thereunder may be adopted  
17 by reference, and other matters relating thereto, are hereby  
18 adopted and made a part of this deed of trust.

19 It is specifically understood and agreed that, until  
20 such time as the note secured by this deed of trust has been paid  
21 in full, the trustors shall not remove any building or improvement  
22 now on the premises, or which may hereafter be erected on said  
23 premises.
