- (7) ANY AMOUNTS REQUIRED HEREIN TO BE PAID BY BORROWER MAY, IF NOT PAID WHEN DUE, BE PAID BY THE GOVERNMENT AND THEREUPON SHALL BE SECURED HEREBY, BEAR INTEREST AT THE RATE BORNE BY THE ABOVE SAID NOTE IF ONLY ONE IS DESCRIBED, OR, IF MORE THAN ONE IS DESABOVE AND SECURED HEREBY, AT THE RATE BORNE BY THE ONE SELECTED BY THE GOVERNMENT IN ITS SOLE DISCRETION, AND BE IMMEDIATELY DUE AND PAYABLE BY BORROWER TO THE GOVERNMENT, WITHOUT DEMAND, AT THE PLACE DESIGNATED IN THE NOTE;
