DECREE SETTLING FIRST AND FINAL ACCOUNT
AND PETITION FOR DISTRIBUTION

ALBERT J. SORHOLUS, Administrator of the above-entitled Estate, having on the 6th day of April, 1972, rendered and filed herein, a full account and report of the Administration of said Estate, which said account was for a final settlement, and having with said account filed a Petition for the final distribution of said Estate, the hearing on said Account and Petition having been set for the 20th day of April, 1972, at the hour of two o'clock p.m. and having come on at such time, and proof having been made to the satisfaction of the Court that due and legal notice of the settlement of said Account and the hearing of said Petition for Distribution had been given as required by law, the Court hereby finds:

1. That said Executor filed no detailed statement of monies received and monies disbursed for the reason that said Executor is entitled to the whole of the residue of said Estate distributed to him absolutely and forever and that said Executor did in his individual capacity waive any accounting or the filing of any detailed statement of monies received and disbursed.

2. That due and legal notice to Creditors of said Estate

- 2 3. That no creditors claims were filed against the Estate

- 9 6. That ALBERT BIALE, ALBERT J. HAMMOND and NORMAN

- 11 the amount of \$23,000.00; that a reasonable fee for said
- 12 Appraisers is the sum of \$10.00 each.
- 13 7. That a reasonable attorney's fee to be allowed to
- 14 CHARLES B. EVANS, JR., Attorney for said Estate, is the sum of
- 15 \$750.00; that CHARLES B. EVANS, JR., has advanced to said Estate
- 16 the sum of \$7.00 and is entitled to be reimbursed for that amount.
- 17 8. That the Administrator waived in open Court, his
- 18 statutory fees and commissions for services rendered as Adminis-
- 19 trator of said Estate.
- 20 9. That there will be closing costs not to exceed \$10.00.
- 21 10. That said Estate is in all respects ready to be
- 22 closed.

27 F. That the sum of \$10.00 be, and the same hereby is,
