Certificate of Location of Lode Mining Claim

THIS IS TO CERTIFY that the BELMONT Lode Mining Claim was located by D. G. Kelly, whose post office address appears below, on the 3rd day of January, 19 13.

The general course of said lode or vein is North east and south east.

The claim is situated in the Unknow (also Antelope) Mining District, Eureka County, State of Nevada, and all requirements of the Laws of the U. S. and the State of Nevada, relating to mining claims, and with the local customs, laws, rules and regulations have been complied with.

The locator claim is 750 feet in a north east direction and 750 feet in a south west direction from the point of discovery, with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim.

The dimensions and locations of the discovery work done on the claim are as follows: The location work has been done on this claim about 400 feet North East of the Location Monument. This claim is located about 5 miles West of Alpha Station on the E. and P. R.R., and about 3 1/2 miles East of the Pete Corletti farm near the head of Dry Creek.

The total cost of such work consisted of at least \$ 200

The corners and side centers of the claim are located and marked as follows:

From the South-West corner, a monument marked S. W. Cor, thence in a North West direction 600 feet to the North West corner, a monument marked N. W. Cor, thence 750 feet in a North East direction to the North side center, a monument marked North SC, thence 750 feet in a North East direction to the North East corner, a monument marked N. E. Cor, thence 600 feet in a South East direction to the S. E. corner, a monument marked S. E. Cor, thence 750 feet in a South West direction to the South side center, a monument marked South SC, thence 750 feet South West to the point of beginning.

Each of the above-described monuments is 4 X 4 Post

All location and discovery work necessary to complete this location had been performed by the 31st day of March, 19 13. This claim is bounded on the North by Lead Bar #5, and on the South by Lead Bar #17.
